Part A: Pupil premium strategy plan

Statement of intent

All members of staff and the Governing Body accept responsibility for 'socially disadvantaged' pupils and are committed to meeting their pastoral, social and academic needs within a caring and nurturing environment. It is our aim that every child no matter their starting point or situation will develop a love of learning and achieve their very best, making at least good progress in every phase of education.

Our current strategy focuses on literacy and numeracy skills as well as supporting those with low self-esteem and/or emotional barriers to learning. Rigorous Pupil Progress Reviews which focus on individuals are the starting point to identifying children requiring additional support or challenge. Targeted provision maps are established and progress towards targets are monitored by the school SENCO and/or subject leaders. Impact of provision is monitored termly and evaluated to ensure outcomes are positive for all. Attendance is monitored half-termly and strategies are in place to promote and encourage excellent attendance. We owe it to all of our children to ensure that they are given every opportunity to succeed.

Part B: Review of outcomes in the previous academic year

Pupil premium strategy outcomes

This details the impact that our pupil premium activity had on pupils in the 2020 to 2021 academic year.

Children in EYFS and Year 1 made good progress from their starting points- Lockdowns and school closures impacted on support at specific times during the year.

Standards in Reading remained good in Years 4-6, Year 1 made good progress from starting points. Years 2 and 3 gaps are wider- Classes with high SEN and Pupil Premium- gaps widened when no face to face teaching.

Equality of opportunity for access to books- all children who requested were given a device for on-line access- Where on line teaching was most successful children made good progress.

Data indicated that gaps in Year 3 were significant compared to other year groups. Focus in summer term on Year 3 - Continued focus on pupil progress enables targeted support in a timely fashion.

Year 1 phonics result continues to be above average- Standards in attainment in phonics were impacted by pandemic- more support required next year for Years 2 and 3 as well as Year 1.

Speaking and listening skills will improve and this will have a positive impact on achievement across the curriculum- Disruption of the pandemic impacted on consistency of provision and approach.

Attendance improved for whole school but still an issue for some disadvantaged children- External issues impacted negatively on attendance of some children. Continue with targeted support and hold parents to account earlier.

Since lockdown some children may experience emotional difficulties- Targeted support provided children with appropriate intervention.
